



## Recipe Corner

### Bolillos bread

Start with

**2 cups water**

**1 ½ tbsp sugar**

**1 tbsp salt**


**2 tbsp butter**

Heat in pan to about 150 degrees **package of yeast added** to above in mixer bowl. *Careful not to kill yeast with heat above 150 degrees* Add **up to six cups of flour** (I also add 3tsp 72% protein gluten) while mixing...then switch to hook to knead until firm and dough pulls away from side of bowl...about five to ten minutes. Oil bowl... form dough into ball and drop into bowl...turn to grease top. Cover with clear wrap and let stand about 1 ½ hours. Punch down and form into 16 shapes like footballs. Place on greased (or parchment paper) cookie sheet about two inches apart. Cover with tea towel and let rise until about double in size. Use egg wash for top and slit tops before placing in pre-heated 375 degree oven for about 35 minutes. It'll be browned and sound hollow when tapped.

**The picture: I used a 2 Liter Pyrex dish and the result was a loaf about a foot wide. Slice and freeze for toast.**





**US Capital “mob riot” January 6, 2021**

*“President Franklin Roosevelt set aside December 7th, 1941, as a day that will live in infamy. Unfortunately, we can now add January 6th, 2021 to that very short list of dates in American history that will live forever in infamy”. said Chuck You Schumer.*

Sounds pretty ominous. Ever try searching the internet to find out what happened? I spent about an hour searching using various search engines and browsers. Got a lot of information about the J6 Samsung phone but nothing more until I ran across the following from Tucker Carlson April 6th, 2021, three months after Schumer’s new date of infamy.

*“A mob of older people from unfashionable zip codes somehow made it all the way to Washington, D.C., probably by bus. They wandered freely through the Capitol, like it was their building or something. They didn’t have guns, but a lot of them had extremely dangerous ideas. They talked about the Constitution, and something called “their rights.” Some of them made openly seditious claims. They insisted, for example, that the last election was not entirely fair. The whole thing was terrifying. And then, as you’ve been told so often, they committed unspeakable violence. By the time thousands of soldiers arrived to restore order, an unarmed woman, an Air Force veteran, lay dead. To this day, that woman is the one completely verified casualty of the insurrection, the only person whose death we can say definitively was caused by specific events on January 6th. We know how she died. She wasn’t a Democratic member of Congress, or even a Joe Biden voter. She was a protestor. Her name was Ashli Babbitt. She was 35. Michael Sherwin, a federal prosecutor in Washington, rounded up about 400 people who were in or near the Capitol on Jan. 6. Here’s Sherwin’s definition of the crimes of the 400 who were arrested: “*

*“ I wanted to ensure, and our office wanted to ensure that there was shock and awe, that we could charge as many people as possible before the 20th. And it worked because we saw through media posts that people were afraid to come back to D.C. because they’re like, “If we go there, we’re gonna get charged.” ... We wanted to take out those individuals that essentially were thumbing their noses at the public for what they did.”*

We now have the J6 committee...laughing stock though it is. The lack of information about the event or what has happened to the still jailed “mob” should underscore the importance of what Elon Musk did with Twitter...main source of LSM “news”.




## Mal Mots
